Dissolve 25 kg **PhytoFulvic 100WP** in 100 liter water (25% solution).

Apply with water-soluble fertilizers in the tank solution through the irrigation system or with a tractor sprayer or as a drench at 4ℓ per young tree and up to 16ℓ for large trees

The 25% solution can also be applied to soluble fertilizers or sprayed/applied on top of granular fertilizers at a ratio of 4 to 8 liter per 25kg fertilizer.

When mixing with fertilizers test for compatibility with a small quantity first and only mix enough for one application.

Always add last to water/fertilizer solution and mix well.

## STORAGE
